Meeting Minutes

I. Welcome & Introductions: Traci welcomed attendees and started the meeting promptly at 10:35 AM. Introductions were given including new supporter Nycole Fox.

- **II. Approval of 11-16-22 Meeting Minutes:** The motion was made by Christian, and seconded by Jen, to approve the 11-16-22, meeting minutes. The motion was unanimously approved.
- III. Review of State EO Monitoring: Traci reported the Federal EO Program Monitors (VEC employees) conducted our local EO monitoring on 2/8 and 2/9. Monitors interviewed board staff and the program operator at the board office then transitioned to the VCW Lynchburg Center. Monitors visually inspected the facility including parking lot, restrooms, and accessible workstation. Additionally, they conducted interviews with both staff and customers. To date, we have not received their report.
- IV. Review of Jobs EQ Regional Demographic Data: The committee discussed regional Jobs EQ demographic data as distributed with the agenda packet. Conversations ensued regarding race demographics including the Hispanic or Latina population at 3% and Asian at 1.4%. Traci advised our Hispanic demographic may be slightly higher as last survey was in 2016. Christian reported Hispanics may not utilize services out of a communication barrier or fear of not being able to relate.

Jen stated she observed a decrease in disability disclosure regionally as opposed to her former home in NJ. Conversation ensued regarding possible reasons for this decrease. The committee considered if it was cultural, embarrassment or families preferred to "handle" this privately. The committee discussed how to change this mindset.
